In reference to the G.O.No.J-12038/1/2009-SGSY-I(226) dated 25.02.2010 of Ministry of Rural Development, Government of India, sanctioning release of the sum of Rs.6,05,20,000/- (Rupees six crore five lakh twenty thousand) only as Grant-in-aid representing Additional instalment of Central Share of fund under SGSY for 2009-2010 at the disposal of 15 (fifteen) DRDAs (now DRD Cell under Zilla Parishad/Mahakuma Parishad) as per Statement given below for implementation of 'SGSY' in the district, I am directed by order of the Governor to state that the Governor has been pleased to accord sanction to the release of a sum of Rs.2,01,73,600/- (Rupees two crore one lakh seventy three thousand six hundred) only in the ratio of 75:25 between the Centre and the State respectively as Grant-in-Aid representing Additional instalment of matching State Share under SGSY for 2009-2010 at the disposal of 15 (fifteen) DRD Cells for implementation of 'SGSY' in the district as per Statement given below, in accordance with the prescribed guidelines and other instructions issued from time to time by this Department and by Government of India.

Form No. 31) from the Pay & Accounts Office-I, Kolkata and deposit the same in the Fund Transfer Account of the DPRD duly opened in the State Bank of India, Kolkata Main Branch, in terms of this Department Notification No. 3116/PN/O/II/3B-5/2005 dated 17.05.2006.

3. The Drawing and Disbursing Officer of the Directorate of Panchayats & Rural Development, West Bengal, shall issue an Advice to the State Bank of India, Kolkata Main Branch, in terms of this Deptt's G.O.No.4825-RD(SGSY)/19F-39/2007(Pt-I) dated 24.06.2008,

for transfer of the shares of fund of the respective DRD Cells as shown in the above Statement, from the Fund Transfer (FT) Account of the DPRD in the SBI, Kolkata Main Branch directly to the designated Bank account of the respective DRD Cells.

4. Project Directors of the respective DRD Cells will submit Utilization report in respect of the fund released herein to this Department as well as to the Ministry of Rural Development in due course.
